# **ANNEX**

## **Guidelines for the Inspection of Life Saving Appliances**

- 1 It is the responsibility of the Captain/Master of each vessel to ensure that all necessary and appropriate life-saving appliances are on board, in date (where appropriate) and in good working order.
- 2 All vessels participating in any part of a Tall Ships Race (Europe) Ltd event may be required to produce their Life Saving Appliances to verify that these items are on board and, where appropriate, in date. The Tall Ships Races International Ltd Race Official may also request that other items identified in the Tall Ships Races International Limited Racing & Sailing Rules and Special Regulations 2019 Edition are on board, but any such inspection shall not in any way absolve the Captain/Master of the vessel from his responsibilities as stated above.
- 3 The Captain/Master of each participating vessel report that the vessel is ready for inspection to the Race Office as soon as he/she is satisfied that his/her vessel complies with the Special Regulations. Please refer to page 1 (and Rule 12.2) for the relevant deadlines. It is not required to fill out the form beforehand.
- 4 Once informed that the vessel is ready for inspection, a Race Official will arrange with the Captain/Master to visit the vessel to ensure that all necessary and appropriate life-saving appliances are on board, in date (where appropriate) and in good working order.
- 5 Should the Race Official have a language difficulty with the Captain/Master or his representative, a request will be made for the designated English-speaking crew member to be present.
- 6 Note that terrestrial mobile telephones *will not be* accepted as alternative means of communication in place of the emergency antennae referred to in Special Rule 3.07 (due to their limited range offshore).
- 7 Note that vessels participating in Category 1 Races must be equipped with either a HF/MF SSB or a Satellite Communications Transceiver System.
- 8 During the inspection the Race Official will indicate on the page reserved for RACE OFFICIAL'S COMMENTS any Life Saving Appliances which he/she has noted as missing or in any way unsatisfactory. This page will then be signed by the Captain/Master or first mate and witnessed by the Race Official's signature.
- 9 On completion of the inspection, the vessel will be either "satisfactory" or "unsatisfactory". Deficiencies identified in items other than Life Saving Appliances will normally result in a recommendation to the Captain/Master, but multiple deficiencies may result in the Race Official recommending to the Race Committee that the vessel should not be permitted to participate in the event for which it was inspected.
- 10 Where a Race Official has made comments in relation to Life-Saving Appliances or any other items, the Captain/Master should request a re-inspection (at a time to be agreed with the Inspector) as soon as the identified deficiencies have been rectified. Refer to Rule 12.2 for the deadline for re-inspection.
- 11 Once designated "satisfactory" the VLSA Check List will normally remain valid for the entire Race Series. However, should there be a change of Captain/Master, the replacement should visit the Race Office to read and sign the Master's Declaration on page 6.
- 12 Deadlines and penalties for submitting the VLSA Check List, and re-inspections (if applicable), are listed in Rule 12.2
